i)? Sample the Index through physical acquisition of a range of equities that, in aggregate, approximate the full index in terms of key risk factors and other characteristics.

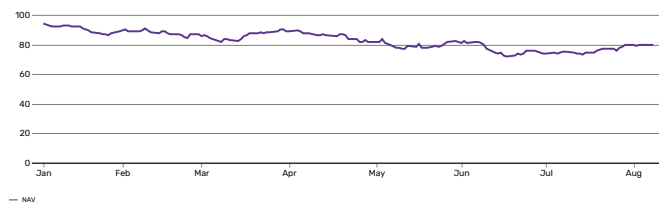
ii)? Remain fully invested and hold small amounts of cash except in extraordinary market, political or similar conditions where the Fund may temporarily depart from this investment policy.

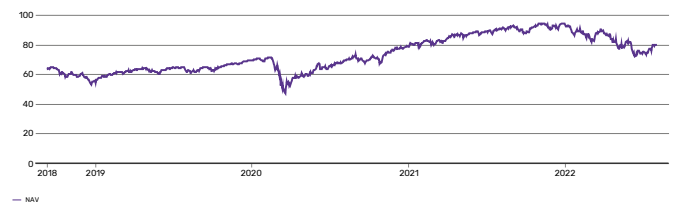
## Net asset value - YTD
