

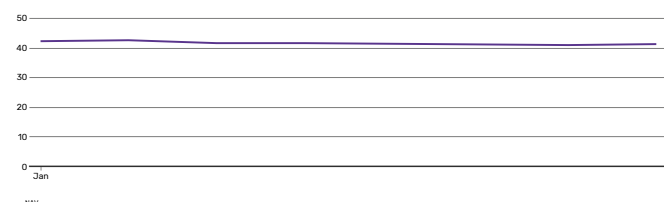

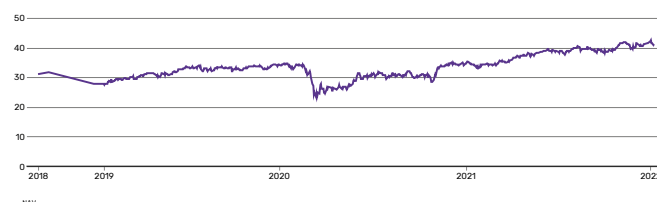
## Net asset value - YTD
