

Xtrackers II EUR Corporate Bond ex Financials UCITS ETF

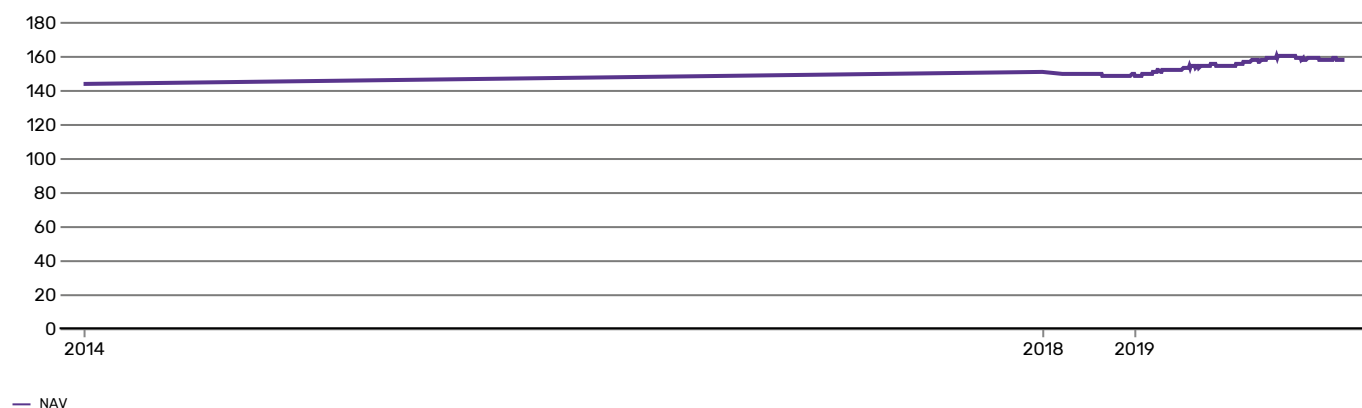
The aim is for your investment to reflect the performance of the Bloomberg Barclays Euro Corporate ex Financial Bond Index (Index). The Index aims to reflect the performance of certain types of tradable debt (bonds) issued by companies which are denominated in Euro, excluding those bonds issued by financial institutions. The composition of bonds on the Index is rebalanced monthly. On each rebalancing date, specific rules are applied to determine which bonds are eligible for inclusion which include a bond minimum time to maturity and amount outstanding and minimum 'investment grade' bond ratings from major ratings agencies. The Index is sponsored by Bloomberg Barclays Indices. To achieve the aim, the Fund will attempt to replicate the Index by buying a portfolio of securities that may comprise the constituents of the Index or other unrelated investments as determined by the investment manager and the sub-portfolio manager, which are DWS Group entities. The Fund may employ techniques and instruments in order to manage risk, reduce costs and improve results. These techniques and instruments may include the use of financial contracts (derivatives). The Fund may also engage in secured lending of its investments to certain eligible third parties to generate additional income to offset the costs of the Fund. No dividends will be paid on your shares. You may redeem your investment on demand on a daily basis.
